Chaplain's Corner



April 15—Tax Day, and a not entirely welcome reminder that we are under orders to render to Caesar (or at any rate the IRS) what is properly due. At least in our day we get to vote for (or against) the people who vote for the taxes and so have at least a bit more voice than the people did in Jesus' day. We should also remember that one of the great signs of Jesus' love is that he ate with tax collectors (and prostitutes and apparently even lawyers).

What then do we owe to the modern day equivalents of Caesar? Broadly speaking, the answer is pretty easy. We are nearly always obligated to obey the

laws in force wherever we are, even laws we don't like or laws we think were unfairly enacted. The main exception is clear: we are not bound by and indeed are obligated to disobey laws that directly violate God's law.

But in fact our duty as Christians goes beyond that. Precisely because we as Americans have the ability to speak and vote freely, we owe all our fellow citizens the benefit of our distinct understanding of human dignity and human flourishing. We don't impose our views; we can and must share them. It is precisely because we see our fellow human creatures as children of God with a transcendent and eternal destiny that we have something more to offer than same-old, same-old political squabbles. In a world of clever lies, we can speak the simple truth.



Deacon Circle By-Laws

Article 1 Name and Association

The Circle sponsored by Roanoke Council 562 of the Knights of Columbus shall be known as Deacon Circle 3807. It shall be sited at Roanoke Catholic School.

As its existence depends on continuing sponsorship by the Roanoke Council 562, the Circle must always defer to its Counselors as representatives of its sponsoring Council.

Article 2 Membership

Membership in Deacon Circle shall be open to all boys from age 12 thru 18 years old. Application for membership shall be by the official Squires application form. Each application must be reviewed and approved by a vote of the Circle members at a regular business meeting.

Article 3 Dues

a. Members of Deacon Circle shall pay annual dues of \$10. It shall be the responsibility of the Bursar to bill each member during the month of September each year. The dues shall only be waived upon the advice of the faculty sponsor, in concert with the Chief Counselor.

b. The Bursar shall issue dues notice in September to each member, and, if a member is in arrears of his dues, re-issue dues notice to him monthly until said dues are paid. The Bursar shall report the names of any member who has not paid his dues by November 1st to the chief Squire, the faculty sponsor and the Chief Counselor.

c. A member reported by the Bursar as being more than three months in arrears of his dues shall be advised of the intent to suspend his membership. If that member fails to pay past dues, his membership shall be suspended December 1st, unless the faculty sponsor, in concert with the Chief Counselor, advises to the contrary.

Article 4 Officers and Their Election

a. The elected officers of the Circle shall include, in order of precedence: Chief Squire, Deputy Chief Squire, Notary, Bursar and Marshall and Sentry. Appointed officers shall included Pole Captain and Arm Captain and various Committee Chairmen as required from time to time. These shall be appointed by the Chief Squire.

i. The Chief Squire shall chair all meetings, appoint the Captains and any committee chairmen needed, and perform other duties as needed.

ii. The Deputy Chief Squire shall assist the Chief Squire in all Circle activities. He will also assume the duties of the Chief Squire when the Chief Squire is absent.

iii. The Notary shall be responsible for recording the minutes of each meeting and reading the minutes, and all communications received by the Circle, at the subsequent meeting. He shall also be responsible for authoring and distributing all Circle communiques approved by the Chief Squire. In the absence of the Notary, the Chief Squire shall appoint a Circle member to take the minutes of the meeting.

iv. The Bursar shall be responsible for maintaining Circle membership records, ordering Council supplies, billing and collecting dues from each member, recording and depositing all money received by the Circle and issuing vouchers, as authorized by the Chief Squire, for payments of debts owed by the Circle, and presenting

such voucher to the faculty sponsor for issuance of a check from the Circle's school account. He shall also see that any such check be mailed to the payee at the proper address.

v. The Marshall shall be responsible for maintaining order during all meetings, for the safe keeping of Circle property and for the proper arrangement of the Circle meeting room. He shall also insure that the necessary paraphernalia is at each meeting, investiture and other ceremonies.

vi. The Sentry shall guard the entrance to the Circle's meeting room, allowing only qualified members to enter. He shall also assume the duties of the Marshall when the Marshall is absent.

b. All Circle members, who are current in their dues, are eligible to hold office.

c. The election of officers shall be held at the regular business meeting in May.

d. The election for each office shall be by paper ballot, unless there is only one nominee, in which case a voice vote may be taken.

e. If any officer fails to attend three successive meetings, and has not previously been excused by the Chief Squire, he shall forfeit his office. The Chief Counselor shall appoint a replacement.

Article 5 Meetings

a. Meetings shall be conducted according to Roberts Rules of Order.

b. Business meetings shall be held at the time and place as decided by the majority of membership present at the September meeting. Either can be changed by a majority vote at a subsequent meeting provided all members have been advised of the proposed change prior to the meeting.

c. A business meeting can only be held if a quorum is present. Five members, three of whom must be elected officers, shall constitute a quorum.

Article 6 Expenditures

Except for assessments by the State or Supreme Councils, moneys of the Circle may not be expended unless approved by majority vote in a regular Circle business meeting, and approved by the Chief Counselor.

Article 7 Amendment of Bylaws

a. Circle bylaws can be amended by two-thirds vote of members at a regular business meeting following the business meeting at which the amendment is proposed and following the distribution of said amendment and notice to vote to all members of the Circle.

b. All changes to the bylaws must be approved by the Board of Trustees of Council 562, which consists of the Grand Knight, Financial Secretary and Trustees of Council 562.
