

#### **Chaplain's Corner**



Several times over the last few years, Pope Francis has mentioned one of his favorite novels—a book called Lord of the World. It's a British science fiction novel written in 1907 that looks ahead about a hundred years (roughly, to now) and doesn't much like what it sees. In the novel's 21<sup>st</sup> century world life is scientifically advanced and generally prosperous but largely without God. Christianity is not quite prohibited but it is certainly disfavored by and decidedly unfashionable in a thoroughly secularized society and government.

The media are implacably anti-Christian and especially anti-Catholic. Euthanasia squads compete with the few remaining priests to provide comfort to the sick and dying. Marriage has been reduced to a contract of convenience that requires no sort of lifetime commitment. Protestant churches have virtually disappeared and Catholic churches are rapidly closing as more and more priests renounce their faith and defect to the secularist side.

The story focuses on several characters: among them, a young priest who is working desperately to re-energize the Church through what we might call a New Evangelization; a youngish and ambitious English politician who seeks to advance his career through hostility to the remnant Church; and the politician's wife who has no use for religion but is increasingly shocked by the growing persecution. In the background is a mysterious American politician who promises a brave new world of universal peace. How does it all end? That would be telling.

The book is available for free on a number of web sites. The language is a little stilted and the plotting a little old-fashioned. It's a worthwhile read, however, and pretty scary. Too many of its predictions seem to be coming true.

# Field Agent's Report

A Founding Notion: Protecting the Breadwinner's Income



While jobs may be safer in 2015, accidents, injuries, and illnesses that can impact your ability to work still happen. Most, in fact, do not happen on the jobsite or place of employment. Did you know that a 2011 study revealed that more than 95 percent of the long-term disability claims on file were not work related?

The Knights have always sought to protect members' families from the "loss" of a breadwinner. I'm sure you know all about Father McGivney's vision for our insurance program. Having this protection counts for something, certainly, but it isn't "yours"; it's provided by the company for which you work at their discretion. It could be eliminated tomorrow.
