

for Roanoke 40 Days for life was held Sunday Sept. 23 at St Elias Church and people from all around the area met to discuss the new campaign. Knights may contact their local parish life group to sign up for a time slot to help keep a prayerful vigil at Planned Parenthood on Peters Creek Road. You may wish to select a time when others are there until you get comfortable with the program.

To this date, St Elias Church has the most time slots filled (Mondays). Good folks from several other denominations are also participating in 40 Days at various times and days. And on Saturday mornings there is usually a crowd of youngsters from Liberty University and Virginia Tech present - youngsters who are fervent about the Life issue. That might be a good time to stop by and get yourself eased into the program. A very nice couple from St. Andrews often treats the students to donuts and chocolate. Feel free to call Knight Shawn Marshall 540.721.2408 if you want any info on the program or access to signs. There are videos and podcasts at 40daysforlife.com which will give you a flavor for the value of standing up for faith and life while praying to end the tragedy of abortion which as Mother Therese said destroys two lives - the child and the mother. Blue Ridge Women's Center offers post abortion counseling as well as lots of prenatal support including free sonograms with a machine donated by KofC. Staff from Blue Ridge have told us it is usually 15 years before a woman will seek post abortion counseling - so it is a sorrow that never departs - and it is important for us to let panicked young women see that other people think the life issue is so important for mother and child that we will stand outside in all kinds of weather to offer them prayers and access to help. Please join us.

A Message From a Life-Long Knight, PGK, PFN and FDD

As a long time member of the Knights of Columbus, I have faithfully served the Order, and the Order has faithfully served me! I look at our Council's rooster and see how many of our members are not listed as insurance members and I wonder why?

During my life as a Knight, I have owned several different insurance products of the Knight's. From the beginning, I owned a whole life policy that I thought would provide a nice cushion for my wife should I die before her. The annual premiums were competitive with other insurance companies, but after about the tenth year, the dividends routinely exceeded the premiums and, in most of those years, I paid zero premiums!

When I was young, and had a young family, I had a substantial term policy. One day, I received a letter from Supreme announcing that, due to favorable experiences, they were reducing my term policy premiums. What business does that?!? A business that puts its customers first! That's who!

Later, when I was at a point in life, and income, that I could use a tax deduction for doing good, charitable giving, I took out a small KC life insurance policy. I paid the premiums, but the owner/beneficiary of the policy was my Diocese. The payments were a charitable tax deduction. [One could also assign ownership of such a policy to KOVAR or to VKCCI, do good and also take a tax deduction.]

Within the last ten years, I have invested in the Knight's long term care insurance because I want to preserve the assets, that I have worked so hard for, so that they are available to my wife, or my children, and not go to a nursing home, or be claimed by the State, if I should have to go into a nursing home or hospice.

The idea of being 'insurance poor' is not a myth! Only you can determine what you need and what you can afford. If you are a widower with no heirs, or are single and intend to remain so, you have no need for life or long term care insurance! If you are married, and maybe have children, then you must be concerned about the future and how they will survive without you. Now, life insurance becomes meaningful.

Perhaps you feel that insurance is a scam, and would rather invest to build a meaningful estate. Today, the Knights also offer a number of investments and financial products that were not available in years past. If they had been, I might be talking about them too! Why? Because the Knights of Columbus have proven themselves trustworthy! And, while they may not earn the largest returns advertised in the industry, they have proven themselves to be prudent stewards of the money entrusted to them, and have always paid a respectable return!

Why am I bothering to write this obvious endorsement? Well actually, it's out of concern for our wives and our children. If you are an owner of a Knights of Columbus insurance policy or an investment product, the whole, vast organization that is the Knights of Columbus, will be at your family's service when you pass away!
